- 2. The bidder is requested to visit the O/o the Superintending Engineer (I/c), AIIMS Guwahati during office hours for site visit before submission of the tender. Agency/Firm is requested to do a proper survey before final submission.
- 3. Tenders shall be submitted in bidder letterhead in a sealed envelope. Tenders not properly sealed shall not be considered.
- 4. The tenders shall be submitted for whole item of works (Annexure-1). Tenderer shall also submit Pan Card, GST Registration and Self Declaration of non-Blacklisting/Debarment, completion certificate of similar works.
- 5. No modification or enhancement of rates shall be considered after opening of tenders. Formal agreement will be executed on non-Judicial court paper of minimum Rs 10/- to be purchased by the agency/firm itself.
- 6. GST/Income Tax etc. will be deducted from total bill as per prevailing Govt. rule.
- 7. In consideration of urgency of work, the approved bidder will be required to start the work immediately after issuance of LOA (Letter of Award).
- 8. If the date of submission of tender is a holiday, it will be opened on next working day.
- 9. A sum equivalent to 10% of awarded value of work will be deducted from the bill towards security deposit which will be released after 6 months after successfully completion of work.
- 10. ED/AIIMS Guwahati may ask for justification of rate of items if found exceptionally lower or higher during evaluation. If the bidder fails to submit proper justification or Competent Authority finds the justification submitted is not satisfactory, the bid of that bidder shall summarily be rejected.
- 11. Executive Director, AIIMS Guwahati reserves the right to reject all or any of the tender without assigning any reasons whatsoever.
