11. The decision of selection committee further to approval of Director, AIIMS Guwahati will be final.
12. Result will be published on AIIMS Guwahati Website after the selection process is over.

TERMS & CONDITIONS

1. **It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience.
