#### **Important Note:**

- All the Eligible/Provisionally Eligible candidates are hereby requested to submit the pending documents mentioned against their name at the time of interview for the same to the Administration Section, AIIMS Guwahati.
- The interview for the aforementioned posts will be held on **23.03.2024** in the Mini Conference Hall of AIIMS, Guwahati. This may be treated as INTIMATION to all eligible/provisionally eligible candidates and no further individual communication of invitation for the interview shall be issued.
- Candidates who wish to appear the interview through Video Conferencing must ensure the following guidelines:
  - A high-speed internet connection to be used by the candidates to avoid any interruption.
  - The face of the candidate should be clearly visible in a prominent manner, through video.
  - No mask to be used while appearing for the interview.
- If any candidate is not able to attend the online interview due to connectivity issues from his/her side, it will be presumed that the candidate has not attended the interview. The decision in this regard by the Competent Authority of AIIMS, Guwahati will be final.

5. To join the interview through video conferencing, candidates are required to click on the hyperlink be sent by the IT Cell/Recruitment Cell of AIIMS, Guwahati in due course of time.
6. The candidature of all the candidates shortlisted for interview is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, experience and reservation etc. and if they are found ineligible at any stage, their candidature will be cancelled.
7. The candidates are required to produce No Objection Certificate (NOC) signed by the Competent Authority of their respective organization and not by the candidate himself if happened to be the Issuing Authority at time of interview. No candidate will be allowed to appear for the interview without NOC as per the condition of the Advertisement.
8. Those candidates who want to appear for interview physically must bring all original documents in support of their eligibility for the post applied for as well as other documents requested as per the Advertisement No. 2-45/2021-22/AIIMS/GHY/ESTT/RECT. GRP-A&B/1027 dated 18.08.2023.
9. The candidates will have to produce the original documents at the time of joining, failing which, their candidature will be cancelled.
10. The candidature of all the candidates shortlisted for interview is purely Provisional subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, experience and reservation etc. and if they are found ineligible at any stage, their candidature will be cancelled.
11. No TA/DA will be paid for attending the interview.
12. The above list is purely tentative and may vary. The decision of the Competent Authority in this regard will be final.
13. If selected (On deputation) the candidate has to join the Institute immediately.
14. Canvassing in favour of candidature both direct and indirect is strictly prohibited. Violation of this code of conduct will be brought to the notice of the Selection Committee, besides the institute reserves the right to cancel candidature of such offending candidate at any point of time, if there is sufficient evidence of canvassing. The decision of Competent Authority in this regard will be treated as final.
