4. No Objection Certificate from the current employer (if in government service).
5. The candidature of all the candidates is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age and essential qualification etc. and if they are found ineligible at any stage, their candidature will be cancelled.
