Buyer Added Bid Specific Additional Terms and Conditions

1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.
2. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.
3. Make in india specific authorisation certificate needs to be enclosed.
4. Buyer Added text based ATC clauses

1. Delivery:- The delivery of the gases shall be made as and when required basis during the validity of the contract period and within the stipulated time as described in the point no. 30 under the heading of **special conditions** of this bid document.

2. Option Clause:- The quantity offered in this tender document is tentative requirement for one year. However, the original requirement may increase/decrease either side up to 50% as per actual requirement of AIIMS, Guwahati. The successful L-1 agency is liable for supply the increased/decreased quantity of requested medical gases on their approved L-1 rates during entire validity period of the contract to AIIMS, Guwahati.

The supplier is bound to accept the order quantity will be placed to him as per requirement of the Institute. The supplier can claim the payment only for the quantity of orders actually supplied and accepted by the purchaser but nothing extra.

3. The successful tenderers shall also provide the name and mobile number of a key person, who can be contracted at any time, even beyond the office hours on holidays. The person should be capable of making arrangement for supply of the desired items even on short notice to AIIMS, Guwahati.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
